

TERMS OF USE OF THE KAREL KOMÁREK FAMILY FOUNDATION WEBSITES

(the “Terms of Use”)

Please read these Terms of Use carefully before using our websites. By accessing and/or beginning to use the websites www.pianadoskol.cz or www.komarekfoundation.org/cs (the “websites”), you consent with the Terms of Use stated below.

COPYRIGHT

The owner and operator of the websites www.pianadoskol.cz and www.komarekfoundation.org/cs is the **Karel Komárek Family Foundation**, a foundation with its registered office at Evropská 866/71, 160 00 Praha 6 - Vokovice ID no.: 06212093, listed in the Register of Foundations administered by the Municipal Court in Prague under file no. N 1525, which is in accordance with the Copyright Act (as defined below) authorized to exercise the intellectual property rights to these websites (the “**Foundation**”).
